Act 2013- 398

- Effective: Immediately (May 24, 2013)
- Repeals code section: 40-12-267
- Removing obsolete language
- Rendered void/null by Section 32-6-61
 - Staggered vehicle registration based on first letter of last name
 - Enacted in 1979



Act 2013- 398

- Effective: January 1, 2014
- Amends code section: 32-6-111.2
- National Guard License Plates
- Additional net proceeds from additional fee
 - To National Guard Foundation instead of Historical Society
 - Foundation use funds furtherance of program and purposes



Act 2013- 398

- Effective: January 1, 2014
- Amends code section: 32-6-64
- Legislative Oversight Committee (LOC) may consider Motorcycle License Plate Applications
- Quantity class 2 only – 1,000 plates
- Same design as passenger plates
- Pre-commitments not combined with passenger plate to meet requirements



Act 2013- 398

- Effective: January 1, 2014
- Amends code section: 32-6-64
- Pre-commitment process for distinctive license plates
- Registrant submits pre-commitment to ADOR
 - County licensing officials no longer accept pre-commitments
 - Electronically submit and pay for pre-commitment
- Organizations not meeting pre-commitment
 - Organizations must wait 1 year to reapply



Act 2013- 398

- Effective: January 1, 2014
- Amends code section: 32-6-67
- Legislative Oversight Committee (LOC) Process
- LOC can consider out-of-state college/university plate applications (32-6-64)
- Amends code section: 32-6-68
- Distribution of Distinctive Plate Additional Fees (\$50.00)
- Remainder distributed to State General Fund
 - No proceeds to sponsoring organization/school



Act 2013- 398

- Effective: January 1, 2014
- Amends code section: 32-6-270
- Fire Fighter License Plate
- Amends definition of retired volunteer fire fighter
 - Include resident volunteer fire fighter retired from out-of-state volunteer fire department
- Amends code section: 32-6-272
- AL Forestry Commission adds qualifying individuals to retired volunteer fire fighter list
 - Firefighters omitted from list must present proof membership in volunteer fire department
 - Certificate signed by chief on AL Forestry Commission form



Act 2013- 398

- Effective: January 1, 2014
- New code section
- New Law Enforcement Memorial License Plate
- Personal passenger or pleasure motor vehicle
- Additional \$50.00
 - \$25.00 State Law Enforcement Memorial
 - \$25.00 State General Fund
- Plate available to any supporter
- Design by State Law Enforcement Memorial in Anniston
 - LOC/Revenue approve plate design
- Honors law enforcement officers killed in line of duty



Act 2013- 398

- Effective: Immediately (May 24, 2013)
- Amends code section: 32-6-58
- Generalizes reference to FHVUT requirements
 - Paid as required by Title 26, USC Section 4481
 - Currently 55,000 pounds and over declared GVWR
- Department amending administrative rule 810-5-1-.233



Act 2013- 398

- Effective: Immediately (May 24, 2013)
- Amends code section: 32-7A-17(d)
- Registration Renewals
 - Driver license/other identifying documents only required for one registered owner
 - Rule 810-5-8-.09 Identification Numbers



Act 2013- 190

- Effective: January 1, 2014
- Breast Cancer Research motorcycle plates
- Additional fee: \$50.00 annually
- Available to all supporters (no limit)
- For display on motorcycles as defined Section 40-12-240
- May be personalized
- No disability access
- Breast Cancer Research Foundation of AL
- Same design as passenger plate (new design as of January 1, 2014)



Act 2013- 224

- Effective: August 1, 2013
- Amends code section: 32-8-64-.2
- Provides for the release of certain liens after 4 years for vehicles 12 or more model years old.
- Exceptions:
 - Vehicles over 12,000 pounds
 - Travel Trailers
- Continue Lien After 4 Years
 - Submit application to Department before 4 years from the original security agreement as recorded on original title.





Mandatory Liability Insurance

- Beginning January 1, 2013, insurance verified utilizing an OIVS (Act 2011-688)
 - Law enforcement, license plate issuing officials and DOR
 - Insurance policy information prepopulated
 - If “unconfirmed” response received
 - Must view evidence of insurance
 - Sample insurance documents
 - www.besuretoinsureal.com





Mandatory Liability Insurance

- Changes effective January 1, 2013:
 - Requirements of License Plate Issuing Officials (32-7A-17):
 - Registration suspended
 - Cannot process registration transaction
 - Reinstate registration upon request
 - Must verify insurance through OIVS or view evidence of insurance



- 2014 Online Renewal – August 1, 2013
- Electronically Update information
- Apply for off-site license



Designated Agent Requirements

- Section 32-8-34 (b), Code of Alabama 1975, requires that **every dealer** shall be a designated agent of the Department.
- New dealers have 60 days to become designated agents.
- Title loan/pawn lenders are required to become designated agents.
