TO: ALL PERSONS, FIRMS, AND CORPORATIONS making sales at retail and/or purchasing tangible personal property for use, storage or other consumption; engaging in the business of leasing or renting tangible personal property; engaging in the renting or furnishing of rooms, lodgings, or accommodations made to transients, in the City of Wetumpka, Alabama and its police jurisdiction (located in Elmore County).

Article 3, Chapter 51, Title 11, et seq., Code of Alabama, 1975 authorizes and empowers municipalities to levy a true sales, use, rental and lodgings tax identical to the corresponding State Tax Laws except for the rates of tax.

The governing body of the City of Wetumpka has adopted Resolution No. 2015-4-20-1 to commence services rendered by the Alabama Department of Revenue in the administration and collection of the sales/use taxes and any other additional taxes for the City of Wetumpka. This Resolution is effective June 01, 2015.

Therefore, your first City of Wetumpka local tax return filed with Alabama Department of Revenue is for the tax period ending June 30, 2015, which is due on or before July 20, 2015. Please remit the City of Wetumpka's local tax to:

The Law requires that Wetumpka local taxes be collected, reported and remitted in the same manner as the State sales, use, rental and lodgings taxes. When you file and pay electronically, the City of Wetumpka local taxes are to be included on the electronic city/county tax return assigned to you (City and County Form 9501). Enter the gross amounts and deductions and then all of the calculations will be done automatically for you. COUNCIL ACTION DECLARED THE FOLLOWING:**


SECTION 1. Administration and Collection by State Department of Revenue. Pursuant to the provisions of Code of Alabama 1975, Section 11-51-207, The Mayor and Council of the City of Wetumpka, Alabama, hereby directs that the Department of Revenue of the State of Alabama to administer and collect all (sales, use, rental, and lodgings) taxes levied and assessed under the provisions of this Resolution to the fullest extent allowed by Alabama law effective date: June 28, 2015.

SECTION 2. The Mayor and the City Clerk of the City of Wetumpka shall provide a certified copy of this Council Action to the Alabama Department of Revenue and shall also provide such other information and take such other steps as may be required by said Department of Revenue to enable it to administer and collect taxes levied and assessed under the provisions of Council Action.
