**Stamps:** County stamps are available in rolls of 15,000 which are machine applied, and sheets of 100 applied by use of a hand iron. Stamps must be purchased in full roll and full sheet quantities.

**Purchases:** County stamp purchases may be made with cash, certified funds (cashier's check, money order, etc.) or Electronic Funds Transfer (EFT). Payments of \$750 or greater are required to be made electronically via EFT. You may choose to make payments by EFT if the amount is less than \$750. **All purchases will be on the cash basis, no consignment orders.** Stamp shipments will be made according to the taxpayer's chosen method of shipment. **An order form MUST be completed by the taxpayer and mailed or FAXED (334/353-1011) to the Department.**

**\*Discount:** A 4.75% discount is allowed on stamp purchases made by qualified wholesalers with a tobacco stamping permit **ONLY**. Insufficient payments will result in loss of the discount and penalty and interest charges will be applied.

**DO NOT combine state stamp payments and playing cards stamp payments with county stamp payments.**
