If the renting or furnishing of rooms, lodgings or accommodations to transients are made outside the corporate limits of the city but within the police jurisdiction, the rates of tax are one-half of those stated above.

ORDINANCE NO. 13-2013

AN ORDINANCE TO ADOPT AND ESTABLISH THE LEVY
OF TRANSIENT OCCUPANCY TAX WITHIN
THE POLICE JURISDICTION OF THE CITY OF MONTGOMERY

BE IT ORDAINED BY THE CITY COUNCIL, there is hereby imposed, levied and assessed against every person, firm, association or corporation engaged in the business of operating hotels, motels, tourist courts, tourist cabins, lodginghouses and roominghouses renting to transients a license tax equal to one-half (½) of that provided, for which or upon which a license tax is levied or required within the corporate limits of the city, of the gross income received by each such person, firm, association or corporation from the renting of rooms or apartments within the police jurisdiction. Provided, further, that except for the amount of the license tax levied within the police jurisdiction of the city, all the other provisions Chapter 16, Article V, extend and apply to the license tax levied within the police jurisdiction.

ORDINANCE NO. 43-2013

AN ORDINANCE REPEALING CHAPTER 16, ARTICLE V, SECTION 16-237

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MONTGOMERY,
ALABAMA,

Section 1. That Chapter 16, Article V, Section 16-237 of the Code of Ordinances for the City of Montgomery, Alabama is hereby repealed in its entirety.

Section 2. This Ordinance shall become effective October 1, 2013.

ORDINANCE NO. 48-2013


AN ORDINANCE AMENDING CHAPTER 16, ARTICLE V, SECTION 16-231

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MONTGOMERY, ALABAMA, that Chapter 16, Article V, Section 16-231 of the Code of Ordinances for the City of Montgomery, Alabama be amended to read as follows:

Sec. 16-231. Levied; rate.

There is hereby imposed, levied and assessed against every person, firm, association or corporation engaged in the business of operating hotels, motels, tourist courts, tourist cabins, lodginghouses and roominghouses renting to transients a license tax equal to 10 percent of the gross income received by each such person, firm, association or corporation from the renting of rooms or apartments within the corporate limits of the city.
