 - Migrate NMVTIS – January 2014







- 2014 Online Renewal – August 1, 2013
- Electronically Update information
- Apply for off-site license
 - \$25 fee
 - Can't exceed 3 per license year
 - Sale can't exceed 10 days
 - Must be obtained 14 days prior to event
 - Section 40-12-51 license from county



Designated Agent Requirements

- Section 32-8-34 (b), Code of Alabama 1975, requires that **every dealer** shall be a designated agent of the Department.
- New dealers have 60 days to become designated agents.
- Title loan/pawn lenders are required to become designated agents.
