Effective January 1, 2020.

The governing body of City of Bay Minette has notified the Alabama Department of Revenue of a change in tax administrators for the collection of their sales, use, rental and lodgings taxes. This change is effective January 1, 2020.

Effective with your taxes for the tax period ending January 31, 2020, which are due on or before February 20, 2020, the City of Bay Minette taxes will be administered by the City.

Your City of Bay Minette sales, use, rental and lodgings taxes may continue to be remitted online through the Alabama Department of Revenue's online filing system My Alabama Taxes (MAT), the 'ONE SPOT' to file: <https://myalabamataxes.alabama.gov>. **NOTE:** A new 4-digit account number may be assigned by Bay Minette, requiring that you do update the "City/County Tax Account #" for Bay Minette on the Local Tax/ONE SPOT return.

Resolution 1019-01
SELF-COLLECTION AND ADMINISTRATION OF SALES/USE TAX, LODGING
AND RENTAL TAX

WHEREAS, The City of Bay Minette desires to begin self-collection and administration of City Sales/Use Tax, Lodging and Rental Tax and any other additional taxes effective beginning the period of January 1, 2020 (with the first collection to be received on or before February 20, 2020); and


WHEREAS, The City of Bay Minette acknowledges that these services have previously been provided by PRA Government Services d/b/a Revenue Discovery Systems (RDS) through Resolution Number 1116-12 authorized contract which will expire on January 1, 2020.

WHEREAS, The City of Bay Minette has requested a proposal by Baldwin County to be engaged as a professionally-qualified Auditing Agency as defined under Section 40-2A-1 of the Code of Alabama to render services on behalf of the City of Bay Minette for 36 months.

NOW, THEREFORE BE IT RESOLVED, AND IT IS HEREBY RESOLVED, THAT THE MAYOR AND CITY COUNCIL OF THE CITY OF BAY MINETTE, agree to begin collecting and administering City sales/use, lodging and rental tax effective beginning with the period of January 1, 2020 and the Mayor (or his designee) is instructed to notify the State of Alabama Department of Revenue immediately of the decision of this Council; and

BE IT FURTHER RESOLVED AND IT IS HEREBY RESOLVED, THAT THE MAYOR AND CITY COUNCIL OF THE CITY OF BAY MINETTE, that the agreement for services with RDS not be renewed for the upcoming term and that the services from Baldwin County be reviewed and that the Mayor (or his designee) is authorized and directed to obtain a contract with Baldwin County for sales, use, lodging and rental tax audit services.


