**Resolution # 2019-07-02  
Of the Blount County Commission**

WHEREAS, on January 15, 2019, the Blount County Commission adopted Resolution 2019-01-05 that requested that Blount County's Legislative Delegation pass a legislative act in the 2019 Regular Session of the Alabama Legislature that would authorize the Blount County Commission to levy a 4% lodging tax to be deposited to the county tourism fund for the promotion of tourism, county beautification, supporting and maintaining park and recreation projects, and maintaining the county's covered bridges; and,


WHEREAS, Blount County's Legislative Delegation did present HB564 for the purposes stated above; and,

WHEREAS, on June 6, 2019, Governor Kay Ivey signed Act 2019-410, which authorizes the Blount County Commission to impose a 4% lodging tax to be used specifically for the purposes stated above and said tax should become effective on the first day of the third month following its passage, approval by the Governor or its otherwise becoming law.

**NOW, BE IT THEREFORE RESOLVED BY THE BLOUNT COUNTY COMMISSION** that a 4% lodging tax be levied to become effective September 1, 2019 and collected in the same manner and subject to the same exemptions as the state lodging tax as provided in Chapter 26, Title 40, Code of Alabama 1975; and


