County of Bullock County Resolution

Resolution No. 2019-06

Whereas, County of Bullock County, Alabama desires to begin self-collection and administration of County Sales/Use Tax and Lodging Tax and any other additional taxes effective beginning the period of October 1, 2019 (with the first collection to be received on or before November 20, 2019); and

Whereas, County of Bullock County, Alabama has been presented a proposal by AVENU INSIGHTS & ANALYTICS of Birmingham dated December 17, 2018, whereby AVENU INSIGHTS & ANALYTICS will perform the services necessary to administer and collect the taxes for the County and the County desires to accept such proposal.

NOW THEREFORE BE IT RESOLVED by the County of Bullock County Commission that the County agrees to begin collecting County sales/use and lodging effective beginning with the period of October 1, 2019 and the Chairman is instructed to notify the State of Alabama Department of Revenue immediately of the decision of this Commission; and

BE IT FURTHER RESOLVED that the proposal presented by AVENU INSIGHTS & ANALYTICS dated December 17, 2018, whereby AVENU INSIGHTS & ANALYTICS will perform the services necessary to administer and collect the taxes for the County, be accepted and the Chairman is hereby authorized and directed to enter a contract with AVENU INSIGHTS & ANALYTICS which conforms to such proposal.

THEREFORE, COMMISSIONER JOHN MCGOWAN, a Commission member, made the motion and COMMISSIONER DON LARKINS, a Commission member, seconded the motion that said resolution be approved, and said resolution passed by majority vote of the Commission, and the County Chairman declared the Resolution so passed.
