Collecting Rental & Lodging Taxes Levied by the City***



WHEREAS, the City of Chelsea, Chelsea, Alabama previously passed Resolution 2019-01-22-713 authorizing the Alabama Department of Revenue to administer and collect the rental and lodging taxes levied by the City of Chelsea effective March 1st, 2019; and

WHEREAS, the City of Chelsea hereby amends Resolution 2019-01-22-713 and desires to become self-administered for the rental and lodging taxes effective March 1st, 2019 (with the first collection to be received on or before April 20, 2019); and

WHEREAS, the City of Chelsea also desires the Alabama Department of Revenue to assist in collection of rental and lodging taxes via online payments through My Alabama Taxes (MAT)/ONESPOT; and

WHEREAS, pursuant to the provisions of Code of Alabama 1975, Section 11-51-207, the City Council of Chelsea, Alabama hereby directs that the Department of Revenue of the State of Alabama shall collect all rental and lodging taxes levied and assessed under the provisions of this Resolution; and

WHEREAS, the City of Chelsea shall provide a certified copy of this Resolution to the Alabama Department of Revenue; and

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Chelsea, Alabama, in a regular council meeting, duly assembled, a quorum being present adopted this Resolution and is effective as of March 1, 2019.






