TO: ALL PERSONS, FIRMS, AND CORPORATIONS engaged in the renting or furnishing of rooms, lodgings or accommodations to transients in **Chilton County**, Alabama

**Effective August 1, 2019**, pursuant to *Section 11-3-11.3, Code of Alabama 1975*, and Resolution No. 05-07-2019 adopted and approved by the Chilton County Commission on May 7, 2019, the Alabama Department of Revenue will begin collecting the Chilton County lodgings tax levied by Legislative Act 2006-391. Your first Chilton County lodgings tax return filed with the Alabama Department of Revenue will be for the month of August 2019, which is due on or before September 20, 2019. The tax rate is as follows:

Lodgings Tax Rate..... 5%

The Law requires that Chilton County lodgings tax be collected, reported and remitted in the same manner as the State lodgings tax. When you file and pay electronically, the Chilton County lodgings tax is to be included on the electronic city/county tax return assigned to you (City and County Tax Return, form 9501). Simply enter the gross amounts and deductions, and all calculations will be done automatically for you. You may file these taxes through My Alabama Taxes (MAT) at <https://myalabamataxes.alabama.gov>.

**A RESOLUTION  
AUTHORIZING THE CHILTON COUNTY ADMINISTRATOR  
TO TERMINATE TAX COLLECTION SERVICES CONTRACT  
AND  
TO AUTHORIZE THE ALABAMA DEPARTMENT OF REVENUE  
TO ADMINISTER AND COLLECT LODGINGS TAXES  
LEVIED BY CHILTON COUNTY, ALABAMA**

**STATE OF ALABAMA**

**BE IT ORDAINED BY CHILTON COUNTY, ALABAMA**, a body corporate, acting by and through the Chilton County Commission (“Chilton County”), as follows:

SECTION 1. **Administration and Collection by Alabama Department of Revenue.** Pursuant to the provisions of the Code of Alabama 1975, Section 11-51-207, and upon the termination of Chilton County’s tax collection services contract with GRS Revenue Solutions LLC d/b/a RDS, Chilton County hereby directs that the Department of Revenue of the State of Alabama shall administer and collect all lodgings taxes levied and assessed under the provisions of this Resolution to the fullest extent allowed by Alabama law.

SECTION 2. **Certified Copy.** Chilton County shall provide a certified copy of this Resolution to the Alabama Department of Revenue and authorizes the Chilton County Administrator to provide such other information and take such other steps as may be required by said Department of Revenue to enable it to administer and collect taxes levied and assessed under the provisions of this Resolution.

**THEREFORE, BE IT RESOLVED BY THE CHILTON COUNTY COMMISSION**, while in regular session on May 7, 2019, at 6:00 p.m., as follows:

1. The Chilton County Administrator is authorized and directed to provide notice in accordance with Alabama Code § 40-2A-12 (1975), of Chilton County’s termination of the current contract for tax collections services with GRS Revenue Solutions LLC d/b/a RDS.

2. The Chilton County Administrator is authorized and directed to provide a certified copy of this Resolution to the Alabama Department of Revenue and to provide such other information and take such other steps as may be required by said Department of Revenue to enable it to administer and collect taxes levied and assessed under the provisions of this Resolution.
