**RESOLUTION LEVYING LODGING TAX AND AUTHORIZING CONTRACT FOR
COLLECTION**

WHEREAS, the Legislature of the State of Alabama approved Act No. 2019-171 during its 2019 Regular Session authorizing the Coffee County Commission to levy a four percent lodging tax and the Commission desires to levy the tax approved by this act; and

WHEREAS, Coffee County desires to begin self-collection and administration of County Lodging Tax and any other additional taxes effective beginning the period of September 1, 2019 (with the first collection to be received on or before October 20, 2019); and

WHEREAS, the Commission has been presented a proposal by AVENU INSIGHTS & ANALYTICS of Birmingham dated June 3, 2019, whereby AVENU INSIGHTS & ANALYTICS will perform the services necessary to administer and collect the taxes for the County and the County desires to accept such proposal.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COMMISSION OF
COFFEE COUNTY, ALABAMA**, as follows:

1. The levy of the four percent lodging tax authorized by Act No. 2019-171 is hereby approved and the tax is hereby levied.

2. The Commission agrees to begin collecting County sales/use, rental and lodging tax effective beginning with the period of September 1, 2019 and the Chairman is instructed to notify the State of Alabama Department of Revenue immediately of the decision of this Council.

3. The proposal presented by AVENU INSIGHTS & ANALYTICS dated June 3, 2019, whereby AVENU INSIGHTS & ANALYTICS will perform the services necessary to administer and collect the taxes for the County, be accepted and the Chairman is hereby authorized and directed to enter a contract with AVENU INSIGHTS & ANALYTICS which conforms to such proposal.

4. That the Chairman of the County Commission, the County Administrator and other representatives or agents of the County Commission of Coffee County, Alabama and the County are hereby severally and further authorized and empowered to take any and all such actions necessary or required to effectuate the intent of this Resolution.
