ORDINANCE
2018-3

AN ORDINANCE AMENDING ORDINANCE 2007-19, THE LICENSE
ORDINANCE, AS HERETOFORE AMENDED BY ORDINANCE 2009-1 AND
2016-3, TO INCREASE THE HEADS ON BEDS USER FEE
FROM \$3.00 TO \$3.50

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
EUFAULA that Ordinance 2007-19, the License Ordinance, as heretofore
amended by Ordinance 2009-11 and Ordinance 2016-3 be further amended
to read as follows.*****

SECTION 27. License Classifications.

721110 Accommodations - hotels, motels, tourist cabins, and similar facilities
\$60.00 plus ~~\$3.00~~ \$3.50 per room

721191 Accommodations - bed and breakfast inns and services \$60.00
plus ~~\$3.00~~ \$3.50 per room

721214 Accommodations - trailer parks, RV parks, and travel parks 1
to 5 spaces \$25.00, 6 to 15 spaces \$35.00, 16 to 35 spaces
\$60.00, 36 and over \$85.00 *plus \$3.50 per space*

721310 Accommodations - rooming houses and boarding houses
\$60.00 plus ~~\$3.00~~ \$3.50 per room

Plus an additional charge of ~~\$3.00~~ \$3.50 per day, per room *or space*, during
the period for which charges are made for such room *or space*. Complimentary rooms *or spaces* will be exempt from this surcharge. All
funds payable under this surcharge shall be reflected separately on the
monthly report/remittance and shall be placed in a restricted fund account
for the use designated herein. This remittance shall be due by the 20th day
of each month following the designated reporting period. Effective
September 2016, if paid timely, a discount is allowed on the per room fee
equal to the discount allowed on the lodgings tax. Failure to remit by the
due date shall result in a penalty of 10%. Two-Third's (2/3) of the funds
generated by this surcharge shall be used exclusively to provide stable
funding source for contractual services provided by the Eufaula/Barbour
County Chamber of Commerce for promotional, advertising, and tourism
based recruitment for income producing events which enhance overnight or
extended visitation to Eufaula Barbour County. One-Third (1/3) of the funds
will go to the Eufaula/Barbour County Chamber's General fund for the
purpose of covering expenses associated with operating the Welcome

Center. However, all the funds generated by the .50 cent increase in the additional per room surcharge provided by this amendment shall be directed by the Chamber to the restricted tourism fund.


The provisions of this ordinance are severable. If any part of the ordinance is declared invalid or unconstitutional, such declaration shall not affect the part which remains.

All ordinance or parts thereof which conflict with this ordinance are hereby repealed.

This ordinance shall become effective on the first day of the month following the expiration of sixty 60 (days) after its passage and approval by the Mayor.


