**RESOLUTION TO CONTRACT WITH GRS GOVERNMENT REVENUE SOLUTIONS, LLC D/B/A RDS FOR THE COLLECTION AND PROCESSING OF SALES AND USE TAX FOR THE TOWN OF GERALDINE, ALABAMA**

A RESOLUTION OF THE TOWN COUNCIL AND MAYOR OF THE TOWN OF GERALDINE, ALABAMA TO CONTRACT WITH GRS GOVERNMENT REVENUE SOLUTIONS, LLC D/B/A RDS FOR THE COLLECTION AND PROCESSING OF SALES AND USE TAX FOR THE TOWN OF GERALDINE, ALABAMA.

**WHEREAS**, the Town of Geraldine, Alabama desires to begin self-collection and processing of the Town of Geraldine, Alabama's sales and use tax beginning on January 1, 2018 with the first collection to be received on or before February 20, 2018, and

**WHEREAS**, the Town of Geraldine has been presented with a proposal by GRS GOVERNMENT REVENUE SOLUTIONS, LLC D/B/A RDS (hereinafter RDS) whereby RDS will perform the services necessary to collect and process the sales and use tax for the Town of Geraldine, and the Town of Geraldine desires to accept such proposal.

**THEREFORE**, it is **RESOLVED** by the Geraldine Town Council and Mayor as follows:

1. That the Town of Geraldine, Alabama agrees to begin collecting the Town of Geraldine's sale and use tax effective beginning on January 1, 2018 with the first collection to be received on or before February 20, 2018, and the Mayor is instructed to notify the State of Alabama Department of Revenue immediately of the decision of the Council and Mayor.
2. That the proposal presented by RDS to the Town of Geraldine dated October, 2017 to perform the services necessary to collect and process the sales and use tax for the Town of Geraldine hereby is accepted, and the Mayor is authorized and directed to execute a contract with RDS which conforms to such proposal, and the Town Clerk is authorized and directed to attest the same.
3. That the Mayor is authorized to execute any other documents necessary, and Kim Cleveland, the Town Clerk, is authorized to attest any other documents necessary to cause this action to take effect.
