TO: ALL PERSONS, FIRMS, AND CORPORATIONS making sales at retail and/or purchasing tangible personal property for use, storage or other consumption; engaging in the business of leasing or renting tangible personal property; engaging in the renting or furnishing of rooms, lodgings, or accommodations made to transients, in the City of Goodwater, Alabama and its police jurisdiction (located in Coosa County).

Article 3, Chapter 51, Title 11, et seq., Code of Alabama, 1975 authorizes and empowers municipalities to levy a true sales, use, rental and lodgings tax identical to the corresponding State Tax Laws except for the rates of tax.

The governing body of the City of Goodwater has adopted Resolution No. 001-2015 to commence services rendered by the Alabama Department of Revenue in the administration and collection of the sales/use taxes and any other additional taxes for the City of Goodwater. This Resolution is effective May 01, 2015.

Therefore, your first City of Goodwater local tax return filed with Alabama Department of Revenue is for the tax period ending May 31, 2015, which is due on or before June 22, 2015. Please remit the City of Goodwater's local tax to:

The Law requires that Goodwater local taxes be collected, reported and remitted in the same manner as the State sales, use, rental and lodgings taxes. When you file and pay electronically, the City of Goodwater local taxes are to be included on the electronic city/county tax return assigned to you (City and County Form 9501). Enter the gross amounts and deductions and then all of the calculations will be done automatically for you. **A RESOLUTION AUTHORIZING
THE ALABAMA DEPARTMENT OF REVENUE
TO ADMINISTER AND COLLECT (SALES, USE, RENTAL, AND LODGINGS) TAXES
LEVIED BY THE CITY OF GOODWATER**

**BE IT ORDAINED BY THE CITY OF GOODWATER OF THE STATE OF ALABAMA,
AS FOLLOWS:**

SECTION 1. Administration and Collection by State Department of Revenue. Pursuant to the provisions of Code of Alabama 1975, Section 11-51-207, the City Council of Goodwater, Alabama hereby directs that the Department of Revenue of the State of Alabama shall administer and collect all (sales, use, rental, and lodgings) taxes levied and assessed under the provisions of this Resolution to the fullest extent allowed by Alabama law.

SECTION 2. Certified Copy. The City of Goodwater shall provide a certified copy of this Resolution to the Alabama Department of Revenue and shall also provide such other information and take such other steps as may be required by said Department of Revenue to enable it to administer and collect taxes levied and assessed under the provisions of this Resolution.

The City Council of Goodwater, Alabama adopted this Resolution at the regular meeting on the 14th of April. This Resolution is effective as of the 1st of May, 2015.
