The governing body of the City of Goodwater has adopted Resolution No. 2016-06 discontinuing the services rendered by the Alabama Department of Revenue in the administration and collection of the sales/use taxes and any other additional taxes for the City of Goodwater. This Resolution is effective February 1, 2017.

Therefore, your last City of Goodwater sales tax return filed with the Alabama Department of Revenue is for the tax period ending January 31, 2017 due on or before February 20, 2017.

City of Goodwater Resolution

Resolution No. 2016-06

Whereas, City of Goodwater, Alabama desires to begin self-collection and administration of City Sales/Use, Rental and Lodging Tax and any other additional taxes effective beginning the period of February 1, 2017 (with the first collection to be received on or before March 20, 2017); and

Whereas, City of Goodwater, Alabama has been presented a proposal by RDS of Birmingham dated December 6, 2016 whereby RDS will perform the services necessary to administer and collect the taxes for the City and the City desires to accept such proposal.

NOW THEREFORE BE IT RESOLVED by the City of Goodwater Council that the City agrees to begin collecting City sales/use tax effective beginning with the period of February 1, 2017 and the Mayor is instructed to notify the State of Alabama Department of Revenue immediately of the decision of this Council; and

BE IT FURTHER RESOLVED that the proposal presented by RDS dated December 13, 2016, whereby RDS will perform the services necessary to administer and collect the taxes for the City, be accepted and the Mayor is hereby authorized and directed to enter a contract with RDS which conforms to such proposal.

THEREFORE, Mary Graham, a Council member, made the motion and Louis Chilots, a Council member, seconded the motion that said resolution be approved, and said resolution passed by majority vote of the Council, and the Mayor declared the Resolution so passed.
