RESOLUTION #2019-07

A RESOLUTION ASSIGNING ADMINISTRATION AND COLLECTION SERVICES OF SALES, CONSUMER'S USE, AND BUSINESS LICENSE FOR THE CITY OF HALEYVILLE TO PUBLIC RESOURCE MANAGEMENT ALLIANCE CORPORATION.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Haleyville as follows:

Section 1: Administration and Collection by Public Resource Management Alliance Corporation. The city council hereby directs that Public Resource Management Alliance Corporation shall administer and collect all sales, consumer's use, and business license taxes under the provisions of this Resolution to the fullest extent allowed by Alabama law.


Section 2: Certified Copy. Pursuant to the provisions of Code of Alabama 1975, Section 11-51-208, the City shall provide a certified copy of this Resolution to the Alabama Department of Revenue at least 30 days prior to the first day of the first month on which the Alabama Department of Revenue will no longer collect the taxes.

Section 3: Effective Date. The effective date for the commencement of these services shall coincide with the termination of the city's current agreement for tax administration services which shall be June 1, 2019 with collection of June taxes to be remitted on or before June 20, 2019.

Adopted and approved this the 1st day of April, 2019.


