Whereas, County of Lowndes County, Alabama desires to begin self-collection and administration of County Sales/Use Tax and any other additional taxes effective beginning the period of February 1, 2020 (with the first collection to be received on or before March 20, 2020); and


Whereas, County of Lowndes County, Alabama has been presented a proposal by AVENU INSIGHTS & ANALYTICS of Birmingham dated July 24, 2019, whereby AVENU INSIGHTS & ANALYTICS will perform the services necessary to administer and collect the taxes for the County and the County desires to accept such proposal.

NOW THEREFORE BE IT RESOLVED by the County of Lowndes County Commission that the County agrees to begin collecting County sales/use and lodging effective beginning with the period of February 1, 2020 and the Chairman is instructed to notify the State of Alabama Department of Revenue immediately of the decision of this Commission; and

BE IT FURTHER RESOLVED that the proposal presented by AVENU INSIGHTS & ANALYTICS dated July 24, 2019, whereby AVENU INSIGHTS & ANALYTICS will perform the services necessary to administer and collect the taxes for the County, be accepted and the Chairman is hereby authorized and directed to enter a contract with AVENU INSIGHTS & ANALYTICS which conforms to such proposal.

THEREFORE, W. Dickson Farrior, a Commission member, made the motion and Joey Barganier, a Commission member, seconded the motion that said resolution be approved, and said resolution passed by majority vote of the Commission, and the County Chairman declared the Resolution so passed.
