The City of Prattville has increased their lodgings fee as shown below.

*The above effective date is in accordance with **Act 2018-150**, which requires all counties and municipalities to notify the Department in writing of a new tax levy or amendment to an existing tax levy at least **60 days** prior to the effective date of the new tax or amendment. Act 2018-150 also provides that the effective date of the new tax levy or amendment of an existing tax levy shall be the first day of the third month following the Department's receipt of proper notification as required by law.

ORDINANCE

[To Amend City of Prattville Code of Ordinances, Chapter 38-Licenses, Taxation and Miscellaneous Business Regulations, Article III, Division 5-Transient Occupancy Tax, Section 38-211-Tax Levied Within City Limits; Amount.]

BE IT ORDAINED by the City Council of the City of Prattville that City of Prattville Code of Ordinances, Chapter 38-Licenses, Taxation and Miscellaneous Business Regulations, Article III, Division 5-Transient Occupancy Tax, Section 38-211-Tax Levied Within City Limits; Amount is hereby amended to read as follows:

Sec. 38-211. - Tax levied within city limits; amount.

- (b) In addition to the privilege or license tax set forth in subsection (a), there shall be an additional \$2.00 lodging fee per occupied room per night levied on the charge for any rooms or lodgings.
- (c) The additional \$2.00 lodging fee collected under subsection (b) shall be expended only for parks and recreation department capital improvement projects.

This ordinance shall become effective January 1, 2020 upon its passage and publication as provided by law.

Each of the provisions of this ordinance are severable; and if any provision shall be declared to be invalid, the remaining provisions shall not be affected but shall remain in full force.

All ordinances, or parts of ordinances, in any manner conflicting here with are hereby repealed.
