**TOWN OF PRICEVILLE RESOLUTION NO. 2018-04**

**AUTHORIZING ADMINISTRATION AND COLLECTION OF  
MUNICIPAL SALES TAXES BY THE MORGAN COUNTY COMMISSION**

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PRICEVILLE, ALABAMA, WHILE IN REGULAR SESSION ON March 26, 2018 as follows:

WHEREAS, it is the intent of the Town of Priceville, Alabama to collect payment of certain privilege, license and excise taxes ("sales taxes") against and in respect to sales made by businesses, uses and transactions of businesses within the Town of Priceville, and its police jurisdiction; and

WHEREAS, the Morgan County Commission, through its Sales Tax Collection Department, possesses the ability and expertise to administer and collect such taxes and does in fact administer and collect sales and use tax due to Morgan County; and

WHEREAS, Act Number 93-657 of the Alabama Legislature authorizes Priceville and the Commission to enter into an agreement for the administration and collection of such taxes by the Commission;

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Priceville, Alabama, that the Mayor of the Town of Priceville is authorized to execute a contract with the Morgan County Commission Priceville engaging the Commission to administer and collect the sales taxes, including late penalties and interest thereon, levied by the Town Council of the Town of Priceville in Ordinance No. 2015-01.

IT IS FURTHER RESOLVED that such contract shall be for a period of three fiscal years, (including the current fiscal year), commencing as of the 1st day of May, 2018 and ending on the 30th day of September, 2020.

This Resolution shall become effective upon its adoption.
