TO: ALL PERSONS, FIRMS, AND CORPORATIONS making sales at retail and/or purchasing tangible personal property for use, storage or other consumption, in the City of Vernon, Alabama and its police jurisdiction (located in Lamar County).

Article 3, Chapter 51, Title 11, et seq., Code of Alabama, 1975 authorizes and empowers municipalities to levy a true sales, use, rental and lodgings tax identical to the corresponding State Tax Laws except for the rates of tax.

The governing body of the City of Vernon has adopted Resolution No. 3-19-2018 to commence services rendered by the Alabama Department of Revenue in the administration and collection of the sales/use taxes, for the City of Vernon. This Resolution is effective May 01, 2018.

Therefore, your first City of Vernon local tax return filed with Alabama Department of Revenue is for the tax period ending May 31, 2018, which is due on or before June 20, 2018. These taxes are to be reported using the Local Tax return in My Alabama Taxes (MAT) at <https://myalabamataxes.alabama.gov>. ORDINANCE 3-19-2018

**AN ORDINANCE AUTHORIZING THE ALABAMA
DEPARTMENT OF REVENUE TO ADMINISTER AND
COLLECT SALES TAXES
LEVIED BY THE CITY OF VERNON, LAMAR COUNTY ALABAMA**

STATE OF ALABAMA

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VERNON OF VERNON, ALABAMA, AS FOLLOWS:

SECTION 1. Administration and Collection by Alabama Department of Revenue. pursuant to provisions of the Code of Alabama 1975, Section 11-51-207, the City Council of the City of Vernon hereby directs that the Department of Revenue of the State of Alabama shall administer and collect all Sales taxes levied and assessed under the provisions of this Ordinance to the fullest extent allowed by Alabama law.

SECTION 2: Certified Copy. City Council of the City of Vernon shall provide a certified copy of this Ordinance to the Alabama Department of Revenue and shall also provide such other information and take such other steps as may be required by said Department of Revenue to enable it to administer and collect taxes levied and assessed under the provisions of this Ordinance.

The City Council of the City of Vernon adopted this Ordinance at the regular meeting on March 19, 2018. This Ordinance is effective as of May 1, 2018.


