The City of Warrior has decreased their use tax automotive rate and confirmed a use tax levy in their police jurisdiction as shown below:

Machines and parts and attachments for machines used in manufacturing tangible personal property	2.000	2.000
Net difference paid for all automotive vehicles, truck trailers, semi-trailers and house trailers	1.750	1.000

If purchases of tangible personal property are stored, used or consumed, outside the corporate limits of the city but within the police jurisdiction of the city, the rates of tax are one-half of those stated above.

ORDINANCE 2015-05

AN ORDINANCE AMENDING ORDINANCE NO. 97-05 PROVIDES LEVY OF PRIVILEGE, LICENSE OR EXCISE TAX AGAINST PERSONS, FIRMS OR CORPORATIONS STORING, USING, OTHERWISE CONSUMING OR ENGAGED IN THE BUSINESS OF SELLING AT RETAIL TANGIBLE PERSONAL PROPERTY OR CONDUCTING PLACES OF AMUSEMENT IN THE CITY OF WARRIOR, ALABAMA, PROVIDES FOR THE COLLECTION OF SAID TAXES: PROVIDES PENALTIES FOR THE VIOLATION OF THIS ORDINANCE

WHEREAS, the Mayor and City Council of the City of Warrior, Alabama (herein collectively referred to as the ACouncil@) have determined that ORDINANCE NO. 97-05 REGARDING LEVY OF PRIVILEGE, LICENSE OR EXCISE TAX AGAINST PERSONS, FIRMS OR CORPORATIONS STORING, USING, OTHERWISE CONSUMING OR ENGAGED IN THE BUSINESS OF SELLING AT RETAIL TANGIBLE PERSONAL PROPERTY OR CONDUCTING PLACES OF AMUSEMENT IN THE CITY OF WARRIOR, ALABAMA, PROVIDES FOR THE COLLECTION OF SAID TAXES: PROVIDES PENALTIES FOR THE VIOLATION OF THIS ORDINANCE shall be amended to reflect certain changes pertaining to the levying of a privilege or license tax within the City of Warrior and within the police jurisdiction of the City of Warrior;

NOW, THEREFORE, be it ordained by the Council of Warrior, Alabama as follows:

1. Amendment. ORDINANCE NO. 97-05, adopted by the Council on February 3, 1997, and as amended from time to time thereafter, is hereby further amended as follows:

The privilege or license tax authorized under ORDINANCE NO. 97-05, Section 1(d) is amended by changing the rate established thereunder to one percent (1%) of the gross proceeds of sale as to any automotive vehicle.

2. The effective date of this amendment shall be November 1, 2015.

3. Publication and Delivery. The Council directs the City Clerk to publish this Ordinance in accordance with the laws of Alabama by causing it to be posted in four conspicuous places within the City.
