TO: ALL PERSONS, FIRMS, AND CORPORATIONS making sales at retail and/or purchasing tangible personal property for use, storage, or other consumption in **Washington County**,

*Sections 11-51-200, et seq., **Code of Alabama 1975***, authorize and empower counties to levy a true sales and use tax and require the Alabama Department of Revenue upon request of the county to collect the

On December 29, 2017, the governing body of Washington County adopted Resolution No. 12-29-17 requesting the Alabama Department of Revenue to begin collecting the county's sales and use tax **effective February 1, 2018** with a due date of March 20, 2018.

The Law requires that Washington County sales and use taxes be collected, reported and remitted in the same manner as the State sales and use taxes. When you file and pay electronically, the Washington County sales and use taxes are to be included on the electronic city/county tax return assigned to you (City and County Tax Return, form 9501). Enter the gross amounts and deductions and all calculations will be done automatically for you. File these taxes through My Alabama Taxes (MAT) at <https://myalabamataxes.alabama.gov>.

**A RESOLUTION AUTHORIZING THE ALABAMA  
DEPARTMENT OF REVENUE TO ADMINISTER AND  
COLLECT SALES, USE, RENTAL, AND LEASING TAXES  
LEVIED BY THE COUNTY OF WASHINGTON**

**STATE OF ALABAMA**

**BE IT RESOLVED BY THE COUNTY COMMISSION OF WASHINGTON COUNTY,  
ALABAMA, AS FOLLOWS:**

SECTION 1. Administration and Collection by Alabama Department of Revenue. Pursuant to the provisions of the Code of Alabama 1975, Section 11-51-207, the County of Washington hereby directs that the Department of Revenue of the State of Alabama shall administer and collect all sales, use, rental, and leasing taxes levied and assessed under the provisions of this Resolution to the fullest extent allowed by Alabama law.

SECTION 2. Certified Copy. The County of Washington shall provide a certified copy of this Resolution to the Alabama Department of Revenue and shall also provide such other information and take such other steps as may be required by said Department of Revenue to enable it to administer and collect taxes levied and assessed under the provisions of this Resolution.

The County of Washington adopted this Resolution at the regular meeting on December 29, 2017. This Resolution is effective as of January 01, 2018 (date).
