Whereas, the said Principal is a Bonded Public Seller or Fleet Producer as defined in Title 40, Chapter 17, Article 3B, Code of Alabama 1975, as amended.

NOW, THEREFORE, if the said Principal shall promptly file with the State Department of Revenue of the State of Alabama true reports, as required by law and shall pay all fees, penalties, and interest imposed by the State of Alabama, and which may now be due or which may hereafter become due by the Principal to the State of Alabama, together with any and all penalties and interest thereon, and shall faithfully comply with the provisions of said Title 40, Chapter 17, Article 3B, supra; then this obligation shall be null and void; otherwise the same shall remain in full force and effect.

This bond shall be effective on and is a continuing bond. The Surety on this bond may be released and discharged from any and all liability to the State of Alabama accruing on this bond after the expiration of thirty (30) days from the date upon which the State of Alabama Department of Revenue has provided written notice to the Principal that the Surety would be released and discharged; provided however, such request shall not operate to relieve, discharge, or release such Surety from any liability already accrued or which shall accrue before the expiration of said thirty (30) day period.

## Instructions for Executing the Compressed Natural Gas/Liquefied Natural Gas Surety Bond

1. The surety must be licensed and duly authorized to do business in Alabama.
2. The bond must be numbered by the surety.
3. The bond must have a Power-of-Attorney attached and be dated the same as the bond.
4. The seal of the surety must be affixed and the bond signed by an agent of the surety who is listed on the Power-of-Attorney.
5. All signatures must be originals.
6. **Facsimiles, photocopies, and signature stamps are not acceptable!**
7. This is a continuous bond and will remain in force until cancellation is authorized by the surety and accepted by the Alabama Department of Revenue.
8. You must use the bond form provided on our website. Reproductions of the bond form will not be accepted.
