A monthly return must be filed on or before the 20th of each month following the month of activity.

Instructions

- Line 1** – Enter the total gallons of gasoline sold within each city listed. Sales within other cities in Cullman County, Alabama should be listed under column 13.
- Line 2** – Self-explanatory.
- Line 3** – Multiply line 1 by line 2, and enter the result.
- Line 4** – Interest is computed at the same rate established by the Internal Revenue Service. Contact this office for the applicable rates.
- Line 5** – Enter 10% of line 3 or \$50.00, whichever is greater, if the return is filed after the due date which is the twentieth of the month following the month of activity.
- Line 6** – Enter 10% of line 3 if payment is remitted after the due date which is the twentieth of the month following the month of activity.
- Line 7** – Enter overpayment and attach a letter of credit.
- Line 8** – Enter the total of lines 3 through 6, subtract line 7.
- Line 9** – Enter the result of adding line 8, columns 1 through 13.

Exemptions

1. Sales to the United States government and National Guard.
2. Sales to Class 1 and 2 municipalities.
3. Sales to city and county governing bodies.
4. Sales to city and county boards of education.
5. Sales to private and church schools.
6. Sales to the Alabama Institute for the Deaf and Blind.
7. Sales to the Department of Youth Services.
8. Sales for use in ships, vessels, barges, locomotives, and railroad equipment.
9. Sales for use in off-road vehicles.
10. Sales for agricultural purposes.
11. Sales of kerosene oil, fuel oil, or crude oil used for lighting, heating, or industrial purposes.
12. Sales of diesel oil, tractor fuel, gas oil, distillate, liquefied gas, kerosene, and jet fuel.
