NOW, THEREFORE, if the said Obligor shall promptly file with the State Department of Revenue of the State of Alabama true reports, as required
by law and shall pay all taxes, penalties, and interest imposed by the State of Alabama, and which may now be due or which may hereafter become
due by the Obligor to the State of Alabama, together with any and all penalties and interest thereon, and shall faithfully comply with the provisions
of said Title 40, Chapter 17, Article 12, supra and Act 2019-2; then this obligation shall be null and void; otherwise the same shall remain in full
force and effect.

In the event that the Obligor herein is required to pay the wholesale oil license fee provided under Title 40, Chapter 17, Article 4, Code of Alabama
1975, as amended, this bond shall also specifically guarantee the payment to the State Department of Revenue of any amounts due by said Obligor
to said Department as to the license levied by said Code Section, and shall also insure the State Department of Revenue against any losses
occasioned by Obligor's failure to comply with any of the provisions thereof.

If the Obligor defaults in payment of this obligation, the State of Alabama is authorized to apply the cash to the above-referenced liabilities. The
collateral shall be applied to the payment of any tax, penalty and interest due under the provisions of the above mentioned laws and the balance,
if any, shall be paid to the Obligor.
