### **DESCRIPTION**

File Name:

This file is for the Monthly Municipal Business License Report Data for all municipal business licenses issued in the preceding month. The first reporting period will be for the month of October 2019 and will be due by November 20, 2019. For each month after, the report will be due on or before the 20th day of the month following the month in which the license was issued. Organizations who issue business licenses on behalf of multiple municipalities may submit all data in a single file each filing period.

Source: Municipality

Destination: Alabama Department of Revenue
Frequency: Monthly (by the 20<sup>th</sup> for most months)
Format: Comma Separated Value (CSV) or Excel (XLSX)

MBL###CCYYMM.csv or MBL###CCYYMM.xlsx

(### = the full city/provider name, CCYYMM = the reporting period)

**File Header:** The file header (1<sup>st</sup> row with column names) should remain in the file when it is uploaded. It

should not be deleted. Please select "Check here to indicate that your file has a header row

with column names" on the upload screen when uploading the file.

### When No Licenses were issued

If a municipality did not issue any business licenses during the month, enter a row for that locality with the "Reporting Period", "Master Locality Code of Municipality" and "License Issued?" fields populated. Enter "N" in the "License Issued?" field to indicate that no licenses were issued for that period and municipality. The remaining fields should be present but empty.

### To create the report, follow these steps:

- Open the Municipal\_Business\_License\_Report\_CSV\_Upload\_Template.csv or Municipal\_Business\_License\_Report\_Excel\_Upload\_Template.xlsx in a spreadsheet program such as Excel.
- **2.** Enter the data described below starting on row two (2). All data fields (columns) are required to be present, however, some fields may not require data in them.
- 3. Save the file with the filename in the format MBL###CCYYMM.csv or MBL###CCYYMM.xlsx (MBL = municipal license, ### = the full city/provider name, CCYYMM = the reporting period)
- 4. Upload the file on the Online Local Tax Reports site: <a href="https://www.alabamainteractive.org/ador\_report/">https://www.alabamainteractive.org/ador\_report/</a> (Note the underscore character between ador and report in the URL.) Be sure to the select the correct File Type (CSV or Excel) and select the "Check here to indicate that your file has a header row with column names" checkbox.
