# State of Alabama Department of Revenue



TO: ALL PERSONS, FIRMS, AND CORPORATIONS making sales at retail and/or purchasing tangible personal property for use, storage or other consumption, engaged in the business of leasing or renting tangible personal property, engaged in the renting or furnishing of rooms, lodgings, or accommodations made to transients, in the City of Tallassee, Alabama and its police jurisdiction (located in Elmore and Tallapoosa County).

Article 3, Chapter 51, Title 11, et seq., Code of Alabama, 1975 authorizes and empowers municipalities to levy a true sales, use, rental and lodgings tax identical to the corresponding State Tax Laws except for the rates of tax.

The governing body of the City of Tallassee has adopted Resolution No. 2024-239 to commence services rendered by the Alabama Department of Revenue in the administration and collection of the sales/use taxes, rental taxes, lodging taxes, for the City of Tallassee. This Resolution is effective September 01, 2024.

Therefore, your first City of Tallassee local tax return filed with Alabama Department of Revenue is for the tax period ending September 30, 2024, which is due on or before October 21, 2024. These taxes are to be reported using the Local Tax return in My Alabama Taxes (MAT) at <https://myalabamataxes.alabama.gov>. Resolution 2024-239

A RESOLUTION AUTHORIZING THE ALABAMA  
DEPARTMENT OF REVENUE TO ADMINISTER AND  
COLLECT SALES, USE, RENTAL, AND LODGINGS TAXES  
LEVIED BY THE CITY OF TALLASSEE

STATE OF ALABAMA

BE IT ORDAINED BY THE CITY COUNCIL OF TALLASSEE, AS FOLLOWS:

SECTION 1. Administration and Collection by Alabama Department of Revenue. Pursuant to the provisions of the Code of Alabama 1975, Section 11-51-207, the City of Tallassee hereby directs that the Department of Revenue of the State of Alabama shall administer and collect all sales, use, rental, and lodgings taxes levied and assessed under the provisions of this Resolution to the fullest extent allowed by Alabama law.

SECTION 2. Certified Copy. The City of Tallassee shall provide a certified copy of this Resolution to the Alabama Department of Revenue and shall also provide such other information and take such other steps as may be required by said Department of Revenue to enable it to administer and collect taxes levied and assessed under the provisions of this Resolution.

The City of Tallassee adopted this Resolution at the regular meeting on June 11, 2024. This Resolution is effective as of Sept. 1, 2024.
