# State of Alabama Department of Revenue



TO: ALL PERSONS, FIRMS, AND CORPORATIONS making sales at retail and/or purchasing tangible personal property for use, storage or other consumption, in the Town of ST. Florian, Alabama and its police jurisdiction (located in Lauderdale County).

Article 3, Chapter 51, Title 11, et seq., Code of Alabama, 1975 authorizes and empowers municipalities to levy a true sales, use, rental and lodgings tax identical to the corresponding State Tax Laws except for the rates of tax.

The governing body of the Town of ST. Florian has adopted Resolution No. 302 to commence services rendered by the Alabama Department of Revenue in the administration and collection of the sales/use taxes, for the Town of ST. Florian. This Resolution is effective December 01, 2024.

Therefore, your first Town of ST. Florian local tax return filed with Alabama Department of Revenue is for the tax period ending December 31, 2024, which is due on or before January 21, 2025. These taxes are to be reported using the Local Tax return in My Alabama Taxes (MAT) at <https://myalabamataxes.alabama.gov>. You can view and verify Town of ST. **this Resolution beginning on December 1, 2024**
