

NOW THEREFORE BE IT RESOLVED by the City of Evergreen Council that the City agrees to begin collecting City Sales/Use and Lodging taxes effective beginning with the period of March 1, 2025, and the Mayor is instructed to notify the State of Alabama Department of Revenue immediately of the decision of this Council; and

BE IT FURTHER RESOLVED that the proposal presented by AVENU INSIGHTS & ANALYTICS dated January 7, 2025, whereby AVENU INSIGHTS & ANALYTICS will perform the services necessary to administer and collect the taxes for the City, be accepted and the Mayor is hereby authorized and directed to enter a contract with AVENU INSIGHTS & ANALYTICS which conforms to such proposal.

THEREFORE, Councilman Jerry Caylor, made the motion and Councilwoman Chesson McDaniel, seconded the motion that said resolution be approved, and said resolution passed by majority vote of the Council, and the Mayor declared the Resolution so passed.
